## INDEPENDENT STUDENTS ONLY Student/Spouse Requesting an IRS Verification of Non-Filing Letter

An IRS Verification of Non-Filing Letter provides proof that the IRS has no record of a filed tax form for the year you requested. Non-Tax filers can request an IRS Verification of Non-Filing of their 2020 tax return status, free of charge, from the IRS by following the steps below:

Download IRS Form 4506-T at https://www.irs.gov/pub/irs-pdf/f4506t.pdf

Complete lines 1 – 4 with the non-filer's information, following the instructions on page 2 of the form.

- Line 5: Leave this section blank; do not enter a third party address.
- Line 6: Leave this section blank.
- Line 7: Select the checkbox on the right hand side for Verification of Non-Filing.
- Line 8: Leave this section blank.
- Line 9: Year or period requested field, enter "12/31/2020".

The non-filer must sign and date the form and enter their telephone number. Only one signature is required when requesting a joint IRS Verification of Non-Filing Letter.

Mail or fax the completed IRS Form 4506-T to the address (or FAX number) provided on page 2 of Form 4506-T. If the 4506-T information is successfully validated, you can expect to receive a paper IRS Verification of Non-Filing Letter at the address provided on the request within 5 to 10 days.

Once you have received your Verification of Non-Filing letter, attach to this form and provide both documents to the Harford Community College Financial Aid office.
