- Nursing applications will not be processed for review if applicant has a financial, admission/readmission or Dean's hold.
- Acceptance and denial <u>letters</u> are mailed from the <u>Nursing Department</u> approximately <u>six to eight weeks after the deadline</u>.
- Criminal background check and drug screening through a specified vendor will be required of all nursing students. Results could impact clinical attendance, program completion, and
